Choose a situation that is: high stakes enough that you feel uncomfortable thinking about addressing it, low stakes enough that using it for practice likely won't result in messing up any chance of having a good relationship with the other person or seriously jeopardizing you getting your needs met if you don't do it perfectly, and 3) timely for the course Slide 3 choosing your practice case There are links below this video to help you choose your practice case, including an exercise you'll fill out and send to me so I can give you feedback. Part of the exercise is to brainstorm ideas about potential situations that might be useful to practice with. To help you think about whether the situations you brainstorm are suitable for collaboration, I've created a checklist for you (it's under this video). Print it out and use it to help you decide on your case.

Slide 8	is it suitable for collaboration?	
	All parties are able to articulate their concerns and their needs and have the capacity to follow through on agreements.

	<ul> <li>All parties are coming to the decision-making process voluntarily.</li> </ul>	

Slide 10	is it suitable for collaboration?	
	I am open to the idea that there may be other solutions which meet my needs as well or better than solutions I may currently favor.

	is it suitable for collaboration?	
	<ul> <li>Participation in a collaborative process does not have the potential to be harmful to either party.</li> </ul>
